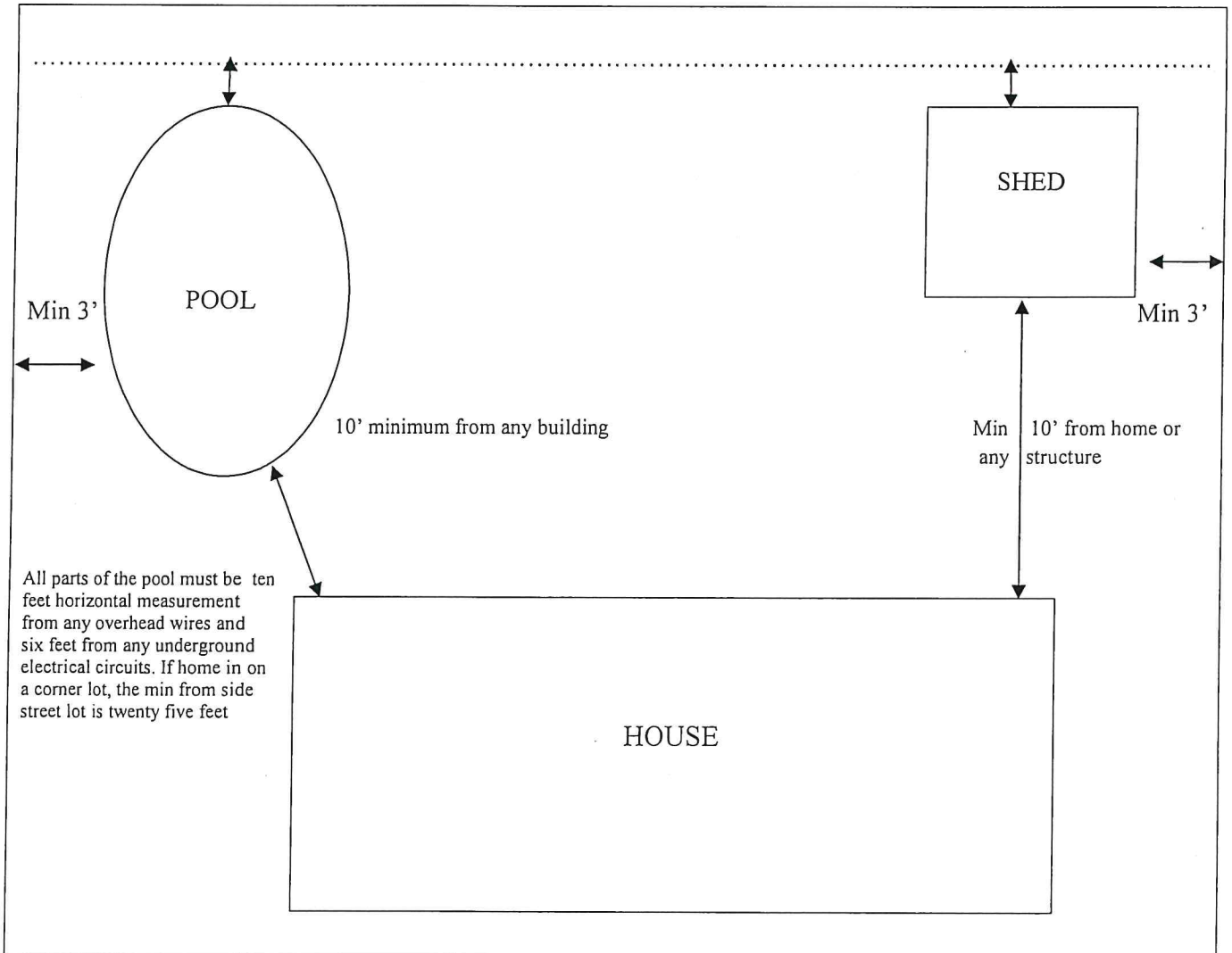
**POOL REQUIREMENTS**

1. Have your pool electrical system installed properly. Water is very good conductor of electricity, when mixed it can kill.
2. See Michigan Code for pools and pool barriers
3. Read manufacturer's instructions before the use and operation of filters and chemicals
4. Discharge of pool water: You are required by the City to direct discharge water to the nearest storm system. This can be done by a hose directed to the open grate in the street or back yard.
5. Pool must be at least 3' from side lot line.
6. Two permits are required: A construction permit and electrical permit for the wiring.

**SHED REQUIREMENTS**

1. Shed must be located in rear yard
2. There must be 10' from the rear of house to the shed.
3. Inspection of foundation, ratwall and 4" thick floor
4. Interior lot: Shed must be kept 3' from lot line, providing an easement does not exist on the side.
5. Corner lot: Shed must be kept 25' from the side street lot line.
6. Construction permit is required. If electrical is being installed, electrical permit is required.
7. If shed is to on posts the post must be a depth of 42" with 8" min clearance from ground to framing.
